CHANGES MADE BY THIS TARIFF:

BASE ROUTE ADDED

Beginning at the intersection of Cadwallader Street and Thompson Street, thence via Thompson Street and 2nd Street to the intersection of 2nd and Stiles Streets; to be operated in the southbound direction only.

BASE ROUTE DISCONTINUED

Beginning at the intersection of Caswallader Street and Thompson Street, thence via Cadwallader Street and Stiles Street to the intersection of Stiles Street and 2nd Street.

ROUTE 57 – FERN ROCK TO WHITMAN PLAZA SHOPPING CENTER

BASE ROUTE

Northbound:

Beginning on the private property of Whitman Plaza Shopping Center, thence via Oregon Avenue, 2nd Street, Snyder Avenue, Moyamensing Avenue, 3rd Street, Germantown Avenue, Oxford Street, American Street, Lehigh Avenue, Front Street, Wingohocking Street, Rising Sun Avenue and Olney Avenue to SEPTA private property located near the intersection of Rising Sun and Olney Avenues.

Southbound:

Beginning on SEPTA private property near the intersection of Rising Sun and Olney Avenues, thence via Rising Sun Avenue, Wingohocking Street, Front Street, Erie Avenue, 2nd Street, Lehigh Avenue, American Street, Cadwallader Street, Thompson Street, 2nd Street, Girard Avenue, 4th Street, Washington Avenue, Moyamensing Avenue, Snyder Avenue, 4th Street and Oregon Avenue to the private property of Whitman Plaza Shopping Center.

TURNBACK LOOP (to be operated as required)

Beginning at the intersection of Front and Luzerne Streets, thence via Luzerne Street and 2nd Street to the intersection of 2nd Street and Erie Avenue.

SPUR ROUTE

Beginning at the intersection of 2nd Street and Oregon Avenue, thence via Oregon Avenue and Columbus Boulevard to the private property of the Packer Marine Terminal; to be operated in either direction.

ALTERNATE ROUTE (to be operated as required)

Beginning at the intersection of Front Street and Erie Avenue, thence via Erie Avenue, Whitaker Avenue, Hunting Park Avenue and Front Street; to be operated in either direction.
