CHANGES MADE BY THIS TARIFF:

BASE ROUTE ADDED

Beginning at the intersection of Ridge Pike and Township Line Road located in the Township of Limerick, thence via Township Line Road, Evergreen Road, Lightcap Road to private property of Philadelphia Premium Outlets, returning via Lightcap Road and Evergreen Drive to the intersection of Evergreen Drive and High Street located in the Township of Lower Pottsgrove.

BASE ROUTE TO BECOME ALTERNATE ROUTE

Beginning at the intersection of Ridge Pike and Township Line Road located in the Township of Limerick, thence via Ridge Pike to the intersection of High Street and Evergreen Drive located in the Township of Lower Pottsgrove.

ROUTE 93 - NORRISTOWN TO POTTSTOWN

BASE ROUTE

Westbound:

Beginning on SEPTA private property of Norristown Transportation Center located near the intersection of Lafayette and Swede Streets in the Borough of Norristown, thence via Lafayette Street, Cherry Street, Main Street, Ridge Pike, Eagleville Road, private property of the Montgomery County Correctional Facility, Eagleville Road, Ridge Pike, Main Street in the Boroughs of Collegeville and Trappe, Ridge Pike, Township Line Road, Evergreen Road, Lightcap Road to private property of Philadelphia Premium Outlets, Lightcap Road, Evergreen Drive, High Street, Hanover Street, King Street, Manatawny Street, High Street Hanover Street and College Drive to the private property of the Borough of Pottstown (College Transportation Center) located in the Borough of Pottstown.

Eastbound:

Beginning on the private property of the Borough of Pottstown (College Transportation Center) located in the Borough of Pottstown, thence via College Drive, Hanover Street, King Street, Manatawny Street, High Street, Evergreen Road, Lightcap Road to private property of Philadelphia Premium Outlets, Lightcap Road, Evergreen Drive, Township Line Road, Ridge Pike, Main Street in the Boroughs of Trappe and Collegeville, Ridge Pike, Eagleville Road, private property of Montgomery County Correctional Facility, Eagleville Road, Ridge Pike, Main Street, Barbadoes Street and Lafayette Street to SEPTA private property of Norristown Transportation Center located near the intersection of Lafayette and Swede Streets in the Borough of Norristown.

ALTERNATE ROUTE

Beginning at the intersection of Ridge Pike and Township Line Road located in the Township of Limerick, thence via Ridge Pike to the intersection of High Street and Evergreen Drive located in the Township of Lower Pottsgrove.

TURNBACK ROUTES (to be operated as required):

1. Beginning at the intersection of Ridge Pike and Eagle Stream Drive located in the Township of Lower Providence, thence via Eagle Stream Drive, Sunderland Drive and Eagleville Road to the intersection of Eagleville Road and Ridge Pike; to be operated in either direction.

2. Beginning at the intersection of Main Street and 8th Street located in the Borough of Collegeville, thence via 8th Street, Chestnut Street and 9th and Main Streets.
