CHANGES MADE BY THIS TARIFF:

BASE ROUTE DISCONTINUED:

1. Beginning at the intersection of Egypt Road and Brower Avenue located in the Township of Upper Providence, thence via Egypt Road to the intersection of Egypt Road and Phoenixville-Collegeville Road.
2. Beginning at the intersection of Main Street and Church Street located in the Borough of Phoenixville, thence via Main Street, Nutt Road, Schuylkill Road, New Street, Main Street in the Borough of Spring City, Main Street in the Borough of Royersford, 10th Avenue and Royersford Road to private property of the Limerick Square Shopping Center located in the Township of Limerick; returning via the same route.

BASE ROUTE ADDED:

1. Beginning at the intersection of Egypt Road and Cider Mill Road located in the Township of Upper Providence, thence via Cider Mill Road, Arcola Road, Campus Drive, Arcola Road, private property of the Providence Town Center, and Phoenixville-Collegeville Road to the intersection of Phoenixville-Collegeville Road and Egypt Road..
2. Beginning at the intersection of Bridge Street and Main Street located in the Borough of Phoenixville, thence via Bridge Street, Church Street and Starr Street to the intersection of Starr Street and Bridge Street.

BASE ROUTE

Westbound:

Beginning on SEPTA private property of the Norristown Transportation Center located in the Borough of Norristown, thence via Lafayette Street, DeKalb Street, 4th Street, Ford Street, DeKalb Street, DeKalb Pike, Saulin Boulevard, Monroe Boulevard, Henderson Road, DeKalb Pike, Allendale Road, Court Boulevard, Mall Boulevard, private property of King of Prussia Plaza, Mall Boulevard, Wills Boulevard, Allendale Road, First Avenue, North Gulph Road, Valley Forge Road, on-ramp to U.S. Highway Route 422 Expressway, U.S. Highway Route 422 Expressway, Trooper Road, Shannondell Boulevard, Egypt Road, Cresson Boulevard, Mill Road, North Drive, Montgomery Avenue, Brower Avenue, Egypt Road, Cider Mill Road, Arcola Road, Campus Drive, Arcola Road, private property of the Providence Town Center, Phoenixville-Collegeville Road, Bridge Street and Church Street to the intersection of Church Street and Main Street located in the Borough of Phoenixville.

Eastbound:

Beginning at the intersection of Church Street and Main Street located in the Borough of Phoenixville, thence via Church Street, Starr Street, Bridge Street, Phoenixville-Collegeville Road, private property of Providence Town Center, Arcola Road, Campus Drive, Arcola Road, Cider Mill Road, Egypt Road, Cresson Boulevard, Mill Road, North Drive, Montgomery Avenue, Brower Avenue, Egypt Road, Shannondell Boulevard, Trooper Road, U.S. Highway Route 422 Expressway, off-ramp to First Avenue, First Avenue, Allendale Road, Wills Boulevard, Mall Boulevard, private property of King of Prussia Plaza, Mall Boulevard, Court Boulevard, Allendale Road, DeKalb Pike, Henderson Road, Monroe Boulevard, Saulin Boulevard, DeKalb Pike, DeKalb Street, Ford Street, 4th Street, DeKalb Street and Lafayette Street to SEPTA Private Property of the Norristown Transportation Center located in the Borough of Norristown.

ALTERNATE ROUTES (to be operated as required):

1. Beginning at the intersection of Mall Boulevard and the driveway leading to private property of the King of Prussia Plaza located in the Township of Upper Merion, thence via Mall Boulevard and North Gulph Road to the intersection of North Gulph Road and First Avenue; to be operated in either direction.
2. Beginning at the intersection of DeKalb Street and 4th Street located in the Borough of Bridgeport, thence via DeKalb Street to the intersection of DeKalb Street and Ford Street; to be operated in either direction.
3. Beginning at the intersection of Lafayette Street and Swede Street located in the Borough of Norristown, thence via Lafayette Street, Cherry Street, Main Street, Markley Street, Danne Hower Bridge and U.S. Route 202 to the intersection of U.S. Route 202 and DeKalb Pike located in the Township of Upper Merion; returning via U.S. Route 202, Danne Hower Bridge, Markley Street, Main Street, Barbadoes Street and Lafayette Street to the intersection of Lafayette Street and Swede Street.
4. Beginning at the intersection of Trooper Road and Audubon Road located in the Township of Lower Providence, thence via Audubon Road, Adams Avenue, Monroe Boulevard, Jefferson Avenue and Van Buren Avenue to the intersection of Van Buren Avenue and Trooper Road; to be operated in either direction.

DETOUR ROUTE (to be operated as required):

1. Beginning at the intersection of Lafayette Street and Swede Street located in the Borough of Norristown, thence via Lafayette Street, Cherry Street, Main Street, Markley Street, Danne Hower Bridge, off ramp for PA 23 East and 4th Street to the intersection of 4th Street and DeKalb Street located in the Borough of Bridgeport; to be operated in the westbound direction.
2. Beginning at the intersection of Ford Street and 4th Street located in the Borough of Bridgeport, thence via Ford Street and Front street to the intersection of Front Street and DeKalb Street; to be operated in the eastbound direction.
